### **Property Tax Assistance** For Seniors

The Avalon Public Library will offer free assistance senior citizens who qualify for New Jersey PTR-1 operty Tax Reimbursement. PTR-1 is a separate ecial senior citizen property tax refind

To qualify you must be 65 or over, must have lived New Jersey continuously for the last 10 years as a meowner or renter, and must have lived or owned ur current home for the last three years. Your to-I income must be less than \$42,000 if single, or 52,000 if married (this includes all income - social curity, pension, interest, dividends, capital gains, et rental income, etc.). You also must have paid the Il amount of property tax due in 2005 and 2006.

Volunteers will be available to help prepare the oplication at the Avalon library at 1:00 Friday afterons now through May 25th by appointment only. The valon library is located at 235 - 32nd Street, Avalon. all 967-7155 to make an appointment.

# **Property Tax Relief Available for Seniors**

Tuest of Miles of them RIO GRANDE — Helen Thompson, a barber here. seems an unlikely source of tax relief information. That's what she has become to many senior citizens who know nothing of property tax relief that may be available to them from the

Thompson told the Herald recently she has taken it upon herself to copy and distribute information to her customers, although the information is widely available from many sources.

Many of her customers are unaware they may qualify for property tax relief. They only see higher taxes after recent revaluations.

Those desiring to talk with someone should call the state's Property Tax Relief hotline at (800) 882-6597.

Those who do not own a computer can use one, free, at any branch of the Cape May County Library.

"You may be eligible for a reimbursement of the difference between the amount of property taxes you paid in the base year (the year you first became eligible) and the amount paid in the year for which you are applying for a reimbursement if you met all the following requirements for the base year and for each succeeding year, up to and including the year for which you are claiming the reimbursement.

By AL CAMPBELL 1. You are age 65 or older or receiving Federal Social Security disability benefits; and

2. You have lived in New lersey continuously for at least the last 10 years, as either a homeowner or a

renter; and

3. You have owned and lived in your home (or have leased a site in mobile home park on which you have placed a manufactured or mobile home that you own) for at least the last 3 years; and

4. You have paid the full amount of property taxes for site fees if you are a mobile home owner) that were due on your home for the base year and for each succeeding year, up to and including the year for which you are claiming the reimbursement; and

5. You meet the income limits for the base year and for each succeeding year, up to and including the year for which you are claiming the reimbursement.

Residents applying for the 2006 reimbursement must have total income for 2005 that is less than \$41,972 for single applicants and \$51,466 (combined income) for married couples, and total income for 2006 that is less than \$43,693 for single applicants and \$53,576 (combined income) for married

If your residence is in a multiple-unit building that you own, and the building has more than four units, you are not eligible for a property tax reimbursement. You are also not eligible if the building has four units or less but more than one commercial unit.

# AARP deals could double its HMO membership

# UnitedHealthcare, Aetna deals to bring \$1.5B in royalties

WASHINGTON — AARP, the advocacy group for seniors, said Monday that it has signed seven-year

agreements with Health care major insurers Aetna and Unit-

ed Healthcare that could double the number of people in its branded health insurance offerings.

Under the agreements:

 Aetna will begin selling health insurance policies for AARP mem-bers ages 50 to 64 by Jan. 1, 2008. initially, they will be available in about half of the states.

UnitedHealthcare will begin

offering a Medicare HMO plan to those over age 65. The plan will have no monthly premium; subscribers will pay co-payments for doctor visits and drugs. It will initially be available in about half of the states, also starting next year. The policies will come with a promise that United will stay in the market for at least two years.

Both insurers will have to meet quality benchmarks, such as boosting the percentage of diabetics who get all recommended treatments. If they don't hit those marks, they risk losing incentive pay.

health care reform," Dawn Sweeney, CEO of AARP Services, said in a written statement. 🔌

Sweeney told reporters that AARP receives an average of \$185 million a year in royalty and reve-nue payments from health insurance products it now offers. It currently has about 7 million policyholders in a variety of pro-grams, all offered by United. They include Medicare prescription drug plans and supplemental insurance that pays for some of the co-payments and deductibles that Medicare does not cover.

AARP expects to double the

we are on the leading edge of number of people in its branded products over the seven years and 64. estimates it will garner an additional \$1.5 billion in royalty payments as a result.

The organization says it will spend the money on ongoing lobbying efforts for health care reform and for measures to improve seniors' long-term financial security, and will spend \$500 million on a new program to help people navi-gate the health care system.

The move is a boost for United, which already is the largest insurer offering Medicare prescription drug policies. It is also a coup for Aetna, which gains access to the 18 million

"By getting the younger members, they position themselves for the future, because there's a good chance they will stay with Aetna when they move into Medicare," says Dan Mendelson, president of Avalere Health, a consulting firm in Washington.

Aetna may also gain some United customers. That's because United currently offers an AARP-branded insurance policy to about 28,000 people ages 50 to 64 in 24 states.

Those members will be offered a choice to switch to an Aetna plan or stay with United, AARP said.
