Anyone wishing to register by mail can do so by requesting mail registration form from the City Clerk or the Cape May County Board of Elections.

VOTING REQUIREMENTS

To vote in Sea Isle City at the Commissions' Election, a person must be a citizen of the United States, a resident of New Jersey, County of Cape May and Sea Isle City for (21) days and shall have attained the legal age of 18 by Commissioners' Election Day, May 8th, 2007.

MUNICIPAL ELECTION

NOTICE is hereby given that the Board of Election will sit at the polling places on Tuesday, May 8, 2007, between the hours of 6:00 AM, and 8 PM, prevailing time, for the purpose of conducting a municipal election for the election of Five (5) Councilmen and One (1) Mayor.

POLLING PLACES

FIRST DISTRICT: Sea Isle City Community Lodge, 300 John F. Kennedy Boulevard, Said District is all that part of the City lying between 1st Street to North Side of 42nd Street, inclusive.

SECOND DISTRICT: Sea Isle City Community Lodge, 300 John F. Kennedy Boulevard, said District is all that part of the City lying between South Side of 42nd Street to North Side of 48th Street, inclusive.

THIRD DISTRICT: Townsend's Inlet Civic Center, 138 – 85th Street, said District is all that part of the City lying between South side of 48th Street to North side of 69th Street, inclusive.

FOURTH DISTRICT: Townsend's Inlet Civic Center, 138 - 85th Street, said District is all that part of the City lying between South side of 69th Street to 94th Street, Inclusive.
