
#### Where would our Passive Park be Located?

Area is

- Bordered on the North by 3<sup>rd</sup> Street
- Bordered on the South by 8<sup>th</sup> Street
- Bordered on the East by Landis Avenue
- Bordered on the West by the Bay

Area estimated at 40 to 50 acres. Extension of wetland bike path to 29<sup>th</sup> St, could expand area to 200 acres.

The area where the Landfill & Paint Chip project is located is an underutilized and under-appreciated asset of our community. Despite the inattention, this area is a source of hidden natural beauty unknown to our residents and visitors. The additional open space provides an opportunity for new and attractive recreational activities.



## Great Egg Harbor to Townsends Inlet (GEH-TI)

Army Corps of Engineers Project

- Army Corps of Engineers Project
- Construction of beachfill & berm along oceanfront
- Scope is 16 miles in length from 32<sup>nd</sup> St in Ocean City down through Strathmere and Sea Isle to the Townsends Inlet bridge
- Federal Project includes NJ Department of Environmental Protection (DEP) as sponsor
- Scope includes periodic nourishment for 50 years
- Project is response to a study investigating hurricane and storm effects and coastal erosion

Great Egg Harbor to Townsends Inlet (GEH-TI) Army Corps of Engineers Project

It is a federal project, so Sea Isle City (as well as Upper Township and Ocean City) gets \$10 of benefit for every \$1 of local investment.

Estimate of cost of initial beachfill approx \$50M

#### Do we need Beach Replenishment?

NJ's sea level is increasing at about twice the global rate because the land is sinking, too
 Look at 11<sup>th</sup> Street and Landis Ave just 9 years ago
 It's not just a North End Problem...take a look at 49<sup>th</sup> Street and the Promenade



## Challenge to the Candidates

- The GEH-TI Project has been stuck in limbo...waiting for the WRDA to get passed
- The WRDA is supposed to be enacted every two years, but Congress has failed to pass this act 3 times in the last 6 years
- WRDA may come up again this month...but then again, it may not
- Sea Isle City may be included in that WRDA...but then again, it may not

## Sewer Extension and FEMA Discount

## Sewer Extension/FEMA Discount

- Sewers in SIC span 21<sup>st</sup> St to 93<sup>rd</sup> St
- North End Sewer Extension a goal of past Master Plans
- 57 structures or 100 housing units
- 17 undeveloped lots fronting Landis or 2<sup>nd</sup> Ave

FEMA = Federal Emergency Management Agency Discount refers to Community Rating System Discount on Flood Insurance

## Background

- 2001 SIC Sewer Extension dropped from County 208 Water Quality Management Plan at insistence of NJ DEP
- Lack of sewers in North End viewed as an obstacle to the SIC community flood insurance discount
  - 10% to 20% community discount in most neighboring coastal towns
- Lack of sewers in North End viewed as an environmental and health concern
- With only 17 developable lots, some view concern regarding overdevelopment as overstated

#### Recent NJDEP response to North End Association

- Area was excluded from 208 Plan due to environmental protection objectives of NJ Coastal Management Program
- Area is a V Zone which is a special flood hazard area subject to significant wave action during severe storms
- They are actively working to acquire undeveloped land in this high hazard area to limit future development
- Extension of sewer service to the area would encourage density of development
- "FEMA's refusal to re-instate SIC's Community Rating System program for discounted flood insurance is due in large measure to numerous documented violations of the National Flood Insurance Program unrelated to septic systems."






#### What age bracket are you?
